RULES & REGULATIONS

Eligibility

1. This competition is an open category to all residents in Singapore.
2. Participants must send in photo entries that represent or capture the festive celebrations during the **Heartland Chingay 2012 @ Ang Mo Kio-Hougang** event on **11 February 2012**.
3. Prizes to be won
 - 1st Prize – \$400 Cash vouchers
 - 2nd Prize - \$250 Cash vouchers
 - 3rd Prize - \$100 Cash vouchers
4. Regardless of the number of entries submitted by the participant, he/she will only stand to win one prize.
5. Entries must be the sole, original and unpublished work of the participant.
6. Digital manipulation that distorts the reality of the photos will not be allowed. Only basic enhancements such as sharpening, contrast adjustment, converting colour images to black & white will be allowed.
7. Any submission containing or implying pornographic, slanderous, obscene or vulgar content would be immediately disqualified.
8. Any entries that have won a prize in any previous international or national photographic competition will be disqualified.

Submission

9. Each participant must submit the photo entry with the registration form containing the following particulars.
 - Name (as in NRIC),
 - NRIC/Passport Number,
 - Address,
 - Mobile Phone/Telephone Number,
 - Email Address,
 - Title of Entry,
 - Caption of the works (less than 100 words)

10. Entries are to be submitted in the JPEG size of a maximum of 1.5MB.
11. Each participant may submit a maximum of **2 photographs** in either colour or monochrome.
12. Each entry must be accompanied by a title and a caption of not more than 100 words which best describe the photo.
13. All entries are to be submitted to civuancc@gmail.com by 25 February 2012
14. You will receive a notification email when the photo(s) is uploaded and ready for voting.
15. The voting date and time is between **11 February 2012, 10pm to 10 March 2012, 10 pm**
16. Entries received after the voting date and time will not be accepted.

Judging

17. Winners will be chosen based on 60% on the number of Facebook Likes and 40% panel of judges.
18. The judges' decision is final and no correspondence pertaining to the judging and short listing process will be entertained.

Organizers' Rights

19. The organizers have the right to disqualify any entry submitted which is non-compliant to the rules and regulations, or copyright infringements; and
20. Will not be liable for any copyright infringement on the part of the participants;
21. Reserve the right to modify the competition prizes and its rules and regulations as and when necessary, without prior notice;
22. Have the right to use the participants' names for promotional purposes without compensation to the participant;
23. The submission of entries signifies acceptance of the above rules and regulations. Non-compliance may result in disqualification.

Copyrights

24. Participants must own the sole copyright of entries. The Organizer and Sponsors reserve the right to disqualify any prize winners who do not own the copyrights to their entries and to recover the prizes that have been awarded to them.
25. The Organizers shall have the right to exhibit, edit the entry's title and use the winning entries for publicity and marketing purposes before, during and after the competition. The winning images shall remain as the property of the Organizer and Sponsors, who reserves the right to use them in any manner deemed fit, without payment of any fee.
26. Each participant who wins a prize warrants that he/she is the owner of the photograph (and all the intellectual property and other proprietary rights in the photograph submitted). The Entrant shall indemnify the organizers against all intellectual property infringement and other proprietary claims including any costs, charges and expenses in respect thereof.
